Food Stamp Retailer Data Released for 15 High Profile Chicago Locations -Communities Asked to Inventory Stores-

A report released today by Mari Gallagher, a leading national expert on the “food desert” issue, helps Chicago residents identify retail stores that are authorized to accept federal food assistance money, and to determine whether these vendors are -- or are not -- providing sufficient healthful food options to their customers.

The study by Mari Gallagher Research & Consulting Group lists retailers that participate in the U.S. Department of Agriculture’s Supplemental Nutrition Assistance Program (SNAP), still known to most Americans as the food stamp program, within a half-mile radius of 15 high-profile locations around Chicago.

The 15 locations include the homes of President Barack Obama and Chicago Mayor Rahm Emanuel, the district offices of U.S. Representative Bobby Rush and State Senator Jacqueline Collins, and Chalmers Elementary School, which is used as one of more than a dozen “bus stops” for Fresh Moves, an alternative mobile grocer that sells fresh produce in under-served minority communities on Chicago’s West Side.

The report stems from Gallagher’s ongoing research into SNAP and whether the billions of dollars that the federal government spends each year on the program -- \$880 million in Chicago alone in 2010, according to figures released last month by Gallagher’s firm -- are being spent effectively to ensure that low-income Americans have access to nutritious food items and not just exclusively junk food.

“SNAP is an extremely important program that should not only continue but expand,” Gallagher said. “Many fine stores participate in SNAP. However, many others fail to meet the low standards set by government.” SNAP’s motto is that the program is the “first line of defense against malnutrition” in the United States.

In dozens of public presentations all over the country beginning in early 2007 including a Congressional briefing, Gallagher has been vocal about her firm’s neutral findings on SNAP. At a sold-out Technology, Entertainment, & Design Conference (TED) in 2009, she showed examples of Detroit SNAP stores that did not comply with federal government standards as well as liquor and convenience stores that were incorrectly coded by the USDA with labels such as “supermarket,” “medium grocery store,” and “small grocery store” (<http://www.youtube.com/watch?v=iEWriN6kh3c>). Her firm developed evidence that these SNAP stores have a statistically significant link to greater premature diet-related death after controlling for other key factors (download *Examining the Impact of Food Deserts on Public Health in Detroit* at: <http://www.marigallagher.com/projects/>). Similar findings concerning links between SNAP stores and poor health have since been found by her firm in several other urban and rural areas.



Gallagher said that responsibility for problems with SNAP does not simply fall on the shoulders of USDA officials, whose resources to monitor the program have dwindled, and who must enforce compliance rules set by Congress that impose questionable nutritional standards.

She cites the current fights over tomato paste in pizza and white potatoes used in French fries as examples. The USDA and the Obama administration have been working to undo the loophole in school meal standards that allows these foods to count as vegetable servings. For example, raw or cooked fruits and vegetables are generally regarded as a serving if there is at least a half-cup on students' plates. By contrast, one-eighth cup of tomato paste on a slice of pizza -- often loaded with high caloric and fat content -- currently counts as a half-cup vegetable equivalent. Low standards in student lunches and in SNAP retailer requirements and monitoring are often the result of the efforts of industry lobbyists.

Gallagher has also expressed concern about the public health impact of a recent development in several states: using another loophole to allow fast food to enter the SNAP program. Watch her September keynote at a Philadelphia hunger symposium (http://www.philabundance.org/2011/10/12/hungersymposium_video/#MariGallagher) or download her firm's *Chicago Food Desert Drilldown*, released last month, which was reported in the New York Times and Bloomberg Business News (report available here: <http://www.marigallagher.com/projects/>).

The corporate push had been led by Yum! Brands Inc., which owns KFC, Taco Bell, and Pizza Hut and operates more than 38,000 locations worldwide. But the company last week retreated from its aggressive campaign in the face of negative publicity, stemming largely from greater awareness about this issue promoted by the Gallagher firm and others, and opposition -- in an unprecedented move -- by a top USDA official. In a November 18 statement, the company conceded that it will cease efforts to enter the SNAP program, according to Yum VP of Government Affairs Paul Carothers who said, "We understand there was little support of this initiative."

Gallagher stated that nutritional needs of low income Americans should be the primary goal of these nutrition programs, not the maximum ability to line the pockets of the food industry, retailers, their lobbyists, or even Congressional campaign funds. "Because of enormous influence in Congress, industry power brokers have been calling the shots, but the recent fast food retreat from SNAP shows that if people get involved, that can change."

Gallagher said the 15 focal points for the study released today were chosen as a way to engage community residents and to recognize local leaders who have been working diligently to improve healthy food offerings. She also noted that Thanksgiving -- a family-oriented holiday that is perhaps the nation's most food-centric occasion -- is an apt time for Americans who enjoy ample food resources to think about the millions of



people who live in “food deserts,” areas that lack basic access to what Gallagher coined as “mainstream” food stores.

Her definitions of “mainstream” and “fringe” food venues were recognized this past October as the thrust of an article in *The Economist* -- a highly respected news magazine with worldwide readership -- which opened with this paragraph describing one of the stores in Gallagher’s data:

“The corner shop on South Honore and West 59th in Englewood is an uninviting sort of place. Those windows that are not bricked up are covered in heavy security grilles; the shopkeeper hides behind a Plexiglas wall. Most of what is on offer is either packaged or carbonated, and is always processed.”

The *Economist* concluded:

“...the opening of a halfway decent grocery store is often the trigger for the arrival of other better-class shops in the area, which then spurs a local economic revival. This could go some way towards reversing a worrying trend pointed out by Ms. Gallagher. She says that there tend to be more diet-related deaths in places where “fringe” retailers accept food stamps. Fringe retailers, by her definition, are those shops that specialize in food high in salt, fat and sugar, plus non-food items such as fizzy drinks. The sad thing, as she points out, is that food stamps are supposed to protect the poor from malnutrition, not make them ill.”

Gallagher emphasizes that corner and other small stores can qualify as mainstream if they also sell healthful foods, so chain and other big box stores are not the only options. New resources have been identified around the country to help these smaller, independent stores improve their facilities and product mix.

The report includes data tables for each location and is being released to the public for the first time today.

The report does not analyze whether the listed stores comply or not with standards for providing nutritious food items, but rather asks public officials and community members to use the data as a guide and be the judge. Its theme is “democratization of data” and the ability of communities to inventory and assess their own local food environments.

Gallagher said her latest report is also a “thank you” to the public officials -- Mayor Rahm Emanuel, Congressman Bobby Rush, State Senator Jacqueline Collins, and others -- and the scores of community and policy leaders who are successfully working to make healthy food choice a reality for everyone.

This will not be the end, she said. Around the New Year holiday, her firm will also compile and post a listing of free online resources that community leaders and students can utilize to develop and map their own neighborhood datasets.



“We see technology as playing an increasingly important role in local expression and action,” Gallagher said. “A stereotype exists that says ‘food desert’ families do not have a home computer connected to the Internet -- many do -- and many have smartphones. How can apps, social media, and other online tools help address the issue and increase the voice of community residents?” In addition to utilizing input from community residents, Gallagher’s group recommends exploring how public health departments -- which already license food stores and visit them regularly -- can help ensure compliance with SNAP rules.

“At this time of Thanksgiving, when families are especially focused on finding and preparing good food and breaking bread together, let us all ask what we can do to improve local food offerings and ensure that SNAP is a catalyst for healthy food, healthy communities, and local jobs and economic revitalization.”

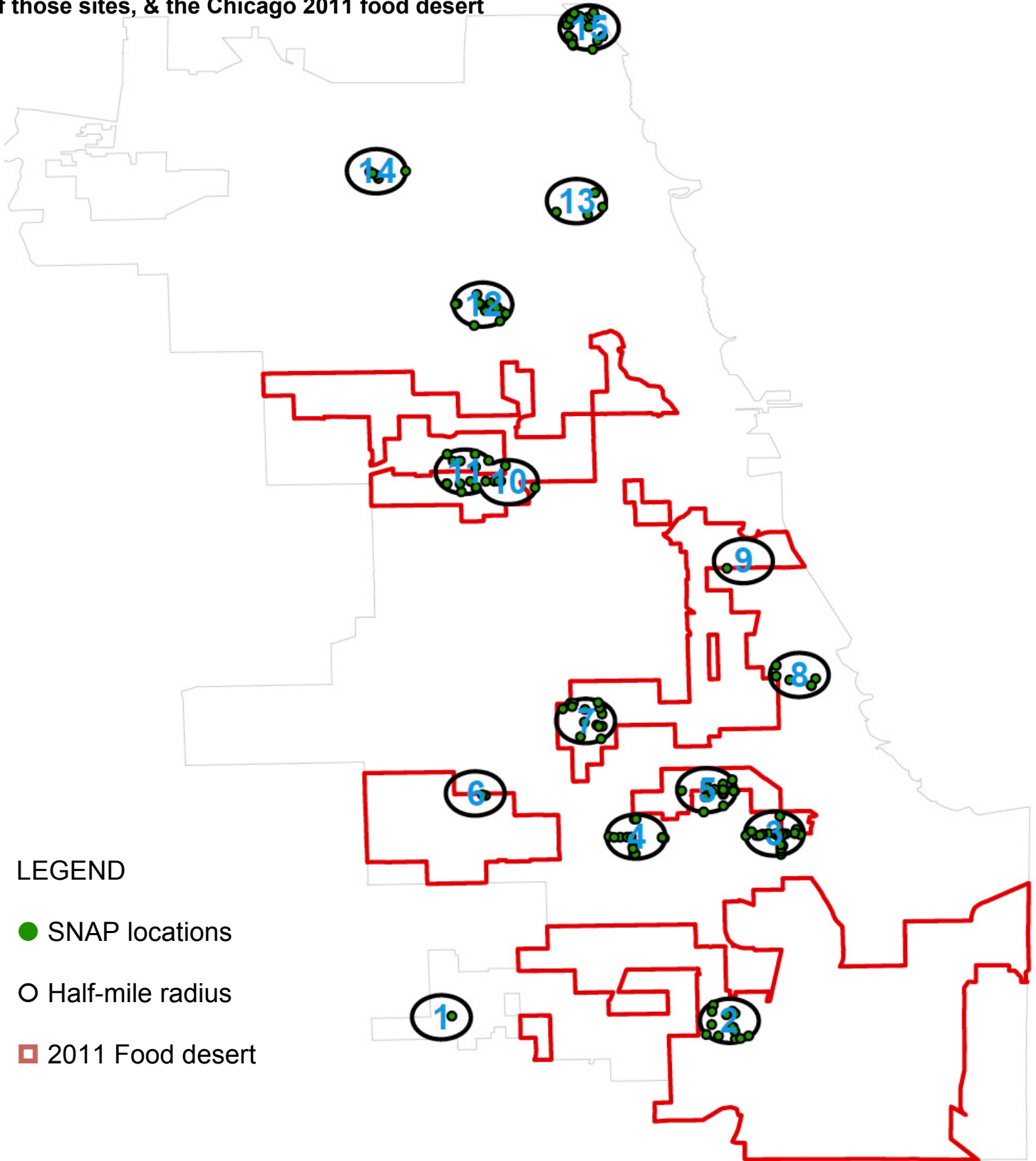

- 1) This table reflects USDA codes, not MG recoding. We suspect that the categories are not completely accurate for the store data within the category. For example, USDA SNAP stores include many liquor stores, dollar stores, gas station mini-marts, pharmacies, and other types of stores. These are accounted for in other category names (such as "combination grocery / other"). Additionally, some stores, such as convenience stores and corner stores, are sometimes coded into other categories, such as medium or large grocery store or supermarket instead of convenience store. This is because, in many cases, the store representative self-selects into the category when filling out the application required to participate in SNAP.
- 2) In the SNAP redemptions figures, some categories are redacted because "N" is small, meaning that the figures would reveal proprietary store information.

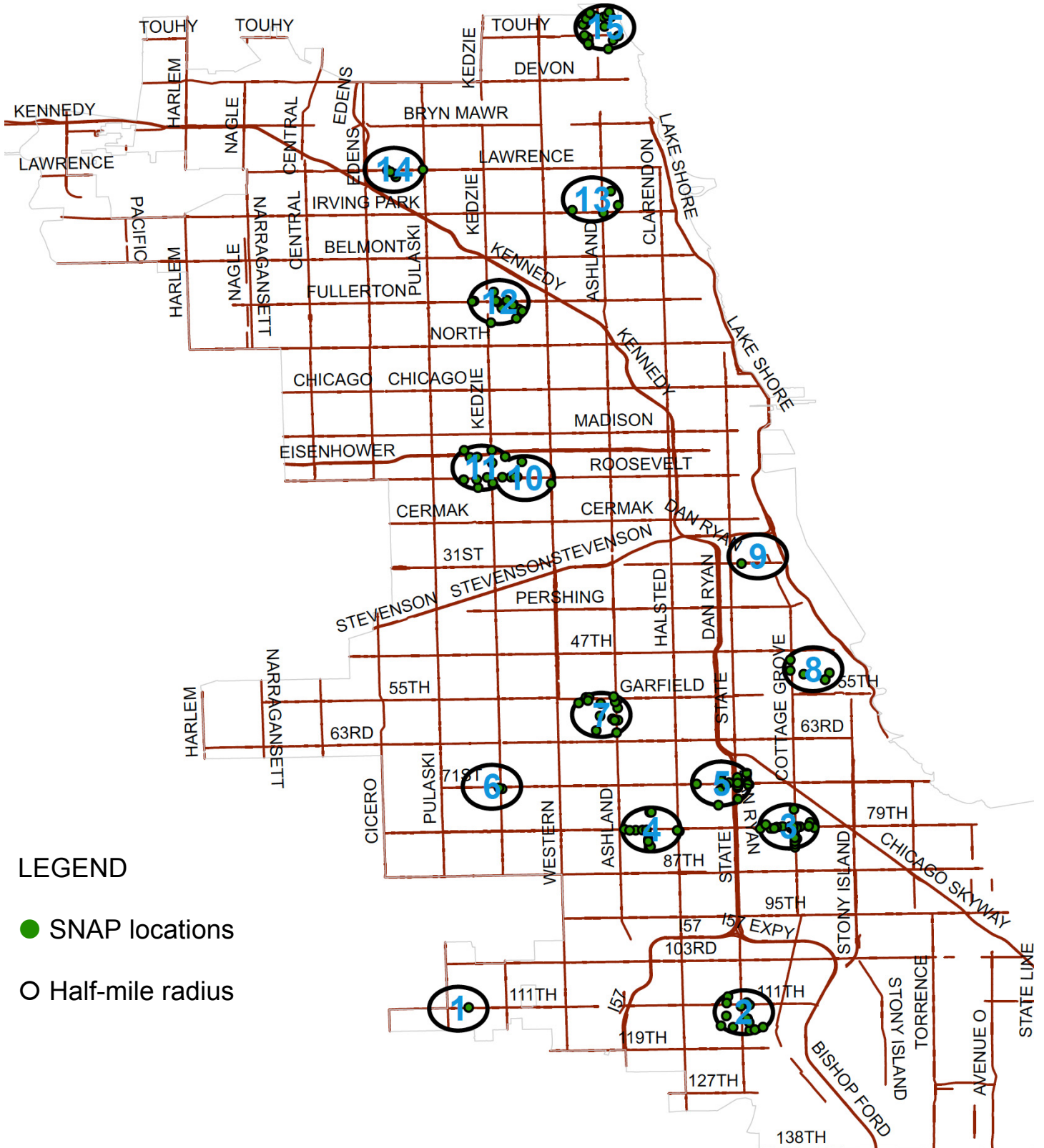

The area around the school is one of the targets of Neighbor Capital's 'FruitRaising' strategy which features a bundle of the "Best Fruit of the Season" sourced by Peapod. Neighbor Capital sells the bundle of fresh fruit through alternative channels such as community based agencies, schools and churches in food desert communities where many local SNAP stores are actually liquor stores that do not offer fruit or any kind of produce. Organizations utilizing the fruit bundle to complement ongoing health, wellness and nutritional promotion are eligible to receive incentives, including free delivery and up to 40% off the premium fruit bundle.
